1. This Invitation for bids follows the general procurement notice for this project that appeared on the Web-site of the New Development Bank (NDB) on July 18, 2019.
2. The Russian Federation has received a loan from the New Development Bank towards the cost of a Development of Water Supply and Sanitation Systems Project and it intends to apply part of the proceeds of this loan to payments under the Contract No. DWSP/ICB/CHB-3 “Upgrading of the pumping station dispatching system. Upgrading of technological and electric equipment at sewage pumping stations (SPS): No.1, No.2, No.5, No.6, No.7, No.9, Glavnaya, Zaovrazhnaya, Volzhsky-2, Vostochny village, DEU, KHP, Solyanoye, TETS-1”.
3. Representative Office of the Saint-Petersburg Foundation for Investment Projects (FISP) in Moscow, acting on behalf of the Ministry of Construction, Housing and Utilities of the Russian Federation, as the Project Implementation Unit (PIU) now invites sealed bids from eligible bidders for procurement of works for upgrading of the pumping stations dispatching system and upgrading of technological and electric equipment at sewage pumping stations, which include procurement of equipment, construction and installation works, testing and commissioning of works.
4. Bidding will be conducted through the international competitive bidding procedures in line with the New Development Bank Procurement policy approved on March 28, 2016 and revised on March, 2018, and is open to all bidders from eligible source countries as defined in the Procurement policy.
5. Interested eligible bidders may obtain further information from the Saint-Petersburg Foundation for Investment Projects (FISP), Representative Office in Moscow and inspect the bidding documents at the address given below workdays from 10.00 hours till 17.00 hours.
6. To participate in the bidding prospective bidders shall submit a written application to the address given below and get an e-mail with complete set of the bidding documents in the English or Russian language.

On August 3, 2021, before 11:30, bidders will submit their bids electronically with the bid security copy in the amount of RUR 8 000 000 or an equivalent amount in other BRICS member country currency. Late bids will be rejected.
